General Information

This is a juried exhibition of Fine Craftwork by the Central Coast Artists Collective's Craftmakers Group. This exhibition will use the gallery floor space for 3D works and ProPanels for 2D works in the Russell Gallery of the **Art Center Morro Bay**. The theme is the artist's interpretation of FRESH! For instance, a newly used material, a fresh idea, nature/spring, etc.

Submission of work to this exhibition constitutes an agreement to the terms stated in the CALL FOR ENTRY and a commitment to show accepted work for the exhibition's duration. By entering this exhibition, artists agree to allow CCAC and Art Center Morro Bay to use submitted images in promotional material.

Eligibility

Entry is open to **Craftmakers** of the Central Coast Artists Collective (CCAC), residing in VENTURA, SANTA BARBARA, SAN LUIS OBISPO, and MONTEREY COUNTIES, with valid memberships for 2025. This exhibit best suits Advanced Beginners - Masters of their craft medium. Submissions should demonstrate a skilled command of your craft, good design, attention to detail, finishing, and presentation. Works must have been made within the past two years and **not shown previously** in SLO County. For information on joining Craftmakers, visit:

Entry and Fees

A maximum of three artworks can be submitted. The entry fee is \$20 for one piece and \$5 for each additional piece. Fees are non-refundable.

In this context, Fine Craft, simply refers to well-made items made by/built by one's hand. A wide range of traditional, contemporary, and folk crafts will be considered in wood, clay, natural fiber, textiles, body adornment, non-traditional sculpture, glass, metal, collage, and mixed media. *Jewelry is encouraged. However, there are limited display options for very small and/or highly valuable pieces. Pins and other securing devices may be used for jewelry or neck pieces.

Deadline

The deadline to apply is midnight on **APRIL 4th**, 2025. Notification will be on or before **APRIL 13th**, 2025.

Sales and Commission

The Morro Bay Art Association will retain a 25% commission on all art sales. The artist will receive 75% of the sales price. All artwork must be for sale. Artwork must remain until the close of the show. Prices set by the artist may not be changed after acceptance. Sold work: The artist is responsible for the delivery arrangements of sold work(s) at the close of the exhibition.

Art Center Morro Bay will not allow artwork that could be seen as pornographic or with strong political implications.

Jurors

Stephanie Arehart - *Bachelor's Degree in Art Education from CSU Los Angeles*, followed by a 33-year career as an *art educator* in SLO County's school districts through Children's Creative Project. She has a strong background as a skilled weaver and textile artist and is currently a *professional studio artist focusing on ceramics*.

Alecia Teague - *MFA Drawing and Painting from Edinburgh College of Art, Scotland*. She has continued education in *Ceramics in and around Sheffield England*. Currently a *Ceramicist and Instructor, and owner of The Pottery* with locations in Atascadero, Grover Beach, and Baywood Park, California.

Lisa Stromsoe - *Past Gallery Owner (Quicksilver Gallery, Cambria and Fine Craft @ Studios on the Park Paso Robles, California), Craft Artist Consultant, Juror (ACC San Francisco, ACC Baltimore Shows) and Studio Partner (Stromsoe Studios, Templeton, California)*.

The Jurors reserve the right to reject, at the time of installation, any artwork that does not meet the standards shown in the images supplied. The artwork must be original. Works may not be substituted after jurying.

Display and Delivery

Please note that we will be sharing the Russell Gallery with the CCAC Photography Group, which will occupy the wall space. We will have access to free-standing Pro Panels for 2D hanging work. Any hanging work submitted should have the appropriate mechanism engineered to work with Pro Panels, which may be an intentionally placed hanging wire, jewelry pins, velcro, or another proper display solution.

* Accepted artwork may be shipped with a prepaid return label to Lisa Stromsoe, Director, with prior approval. The shipping address will be provided at that time.
